

Know the Proper Way to Display the Flag

Many people like to display the American flag but aren't aware of the rules associated with this activity. For reference, here are guidelines from the United States Flag Code:

- It's the universal custom to display the flag only from sunrise to sunset. However, the flag may be displayed 24 hours a day if properly illuminated during the hours of darkness.
- The flag should only be flown in fair weather, unless the flag is designed for inclement weather use.
- When displayed either horizontally or vertically against a wall, the union should be uppermost and to the observer's left.
- The flag should never be displayed with the union down.
- The flag should never touch anything beneath it such as the ground or the floor.
- When a flag is in such condition that it's no longer a fitting emblem, it should be destroyed in a dignified way, preferably by burning.

We encourage you to display the flag this Memorial Day, May 29th, and hope your family can spend meaningful time together to honor those you've lost.



Answers to Your Questions About Live TV Streaming

Live TV streaming services—such as DirecTV Stream, fuboTV, Hulu + Live TV, Philo, Sling TV, and YouTube TV—deliver prime-time network shows and sports over your internet connection. That's why they're often referred to as cable replacements.

If you're thinking about switching from cable TV to a live TV streaming service, you'll want to do your homework to select the service that will provide the channels you most want to watch. To help you get started, here are the answers to frequently asked questions:

What channels are available through live TV streaming services?

Each service offers a different number and variety of channels. To compare, you can visit **gostreamnow.com/venture/channel-lineup**.

How much does a live TV streaming service cost?

The price varies from service to service, but most cost between \$25 and \$75 per month. This makes live TV services a less expensive alternative to cable.

Can I get a free trial for a

live TV streaming service? Yes, many of these services offer free trials. Check their websites for details on current offers.



After I subscribe, how many people in my family can watch a live TV streaming service at the same time?

Most services offer subscribers the ability to stream to two or three devices simultaneously.

Will I be locked in a contract?

No. Live TV streaming services are all month-to-month with no commitment. You can cancel at any time without penalty.

Which devices can I use to stream live TV?

Live TV streaming services work with smartphones, tablets, computers, and streaming devices like Roku, Fire TV, Chromecast, and Apple TV.
