Notice of Capital Credit Allocation

Venture Communications is proud to announce the approval of a \$12,517,209 capital credit allocation for the year 2022. The allocation was distributed among members who had services with the cooperative in 2022. Allocation statements were printed on the May 2023 billing statement.

Statements were mailed to all members who no longer have service with Venture Communications. <u>The allocation amount cannot be applied as a credit to your Venture</u> <u>bill and is not payable at this time.</u> Cash payment of credits will be made only when a general retirement is distributed to the whole membership or to an estate.

Explanation of Capital Credit Allocation Statement

- 1. Telephone Number or other Communication Service.
- 2. Your member number with Venture Communications.
- 3. Year of Allocation.
- 4. The amount of service used during the calendar year.
- **5.** Amount that is allocated to the customer for the calendar year based on the total patronage. If you divide the allocated amount by the total patronage in this case you will see that this account received nearly 67 cents for every dollar they paid into Venture Communications.
- **6.** Allocated amount for 2022.
- 7. Allocated amount accumulated from previous years.
- **8.** Total amount of allocation through the current year. This is not the amount of the check you may receive later in September, and cannot be deducted from your phone bill.
